I hereby acknowledge receipt of the above-mentioned e-mail correspondence, the content of which is noted.

Kindly be advised that this Office received e-mail communications from the son-in-law of Mr Sons on 30 September 2021 where it was reported that Mr Sons will not be able to make the deadline as he is struggling to travel due to his ill health. He further advised this Office that Mr Sons is in the process of obtaining the necessary legal representation so as to enable him to lodge his representations to this Office.

Justice in our society, so that people can live in freedom and security


In respect of Mr Els: this Office received a formal communication from the office of the State Attorney on 30 September 2021, advising this Office that Adv Fanus Coetzee, SC has been instructed to represent Mr Els. They further requested to be provided with a copy of the docket and the relevant court transcripts so that they can prepare proper representations to this Office.

It is expected that Mr Sons will also be provided with legal assistance from the office of the State Attorney, seeing that the SAPS already gave instructions in respect of Mr Els.

Copies of the relevant dockets (which include copies of the court record of the second inquest proceedings) will have to be made available to the legal representatives of Mr Sons and Els in order to enable them to prepare their representations to this Office.

Due to the above developments, this Office will grant Mr Sons and Mr Els with an extension to **25 October 2021** to facilitate the handing over of the requested documents and for them to prepare their representations.
