The facts contained herein, save where the contrary appears from the context, fall within my personal knowledge and are the best of my knowledge and believe, true and correct.

I have been approached by the Chief Evidence Leader Advocate Semanya who investigate cases as per the Judiciary Commission of Inquiry in relation to the Truth and Reconciliation Commission issued by Proclamation Notice 264 of 2025 to depose an affidavit in this matter. This is confirmed by a written letter received from Advocate Semanya dated 2026-03-11.

This affidavit is deposed of subsequent to above mentioned letter and my meeting with the Evidence Leaders dated 2026-03-26.

My appointment as the Provincial Commissioner of Free State commenced from 2011 till 2013. I was also the National Commissioner of the South African Police Service from 2017 till 2022.

During execution of my duties in above positions, I never encountered any reports or information relating to the TRC cases that were brought to my personal attention whether official or unofficial. I also do not have any information related to the TRC in my possession in my private capacity.

Neither did my predecessor as the Provincial Commissioner of the Free State, Lieutenant General Sengani nor did Lieutenant General Mothiba as Acting National Commissioner

I know and understand the contents of this statement.

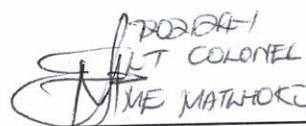
